- 1. General** Unless otherwise expressly agreed in writing by a duly authorized representative of. Aniara Diagnostica, Inc. ("Aniara"), the terms and conditions contained herein constitute the entire agreement between the parties with respect to the subject matter hereof and supersede all prior communications and agreements. Acceptance by Aniara of Purchaser's order, or Purchaser's acceptance of Aniara's proposal, is expressly limited to and conditioned upon Purchaser's acceptance of these terms and conditions that may be changed or waived except in a writing signed by the parties. "Products" as used herein shall include products, parts and accessories furnished to Purchaser by Aniara.
- 2. Delivery/Risk of Loss** Unless otherwise expressly agreed in writing, the Products shall be delivered F.O.B. point of shipment. Aniara reserves the right to deliver in installments. Notwithstanding any agreement with respect to delivery terms or payment of transportation charges, risk of loss or damage for the Products shall pass to Purchaser and delivery shall be deemed to be complete upon delivery to a private or common carrier at the point of shipment.
- 3. Acceptance/Rejection** Purchaser shall notify Aniara, in writing, of any refusal to accept part or all of any shipment of Products delivered here under (including the reasons for any such refusal) within seventy-two (72) hours after delivery. Failure of such notice shall constitute Purchaser's acceptance of the entire shipment. Upon any wrongful refusal of Purchaser to accept delivery, Aniara at its election may retake or resell the Products and recover from Purchaser any damages suffered, including repossession, transportation, selling and advertising costs and the cost of any suit to enforce Aniara's rights hereunder.
- 4. Price** Unless otherwise expressly agreed in writing, the price for the Products shall be Aniara's prevailing price at the time the Products are shipped to Purchaser. The price for the Products does not include any federal, state or local sales, use, excise, value added, gross receipts, or other like taxes which may now or hereafter be applicable to, measured by or imposed upon the Products, their purchase, sale, replacement, value or use, or any other services performed in connection therewith.
- 5. Payment** Unless otherwise expressly agreed in writing, payment is due thirty (30) days from the date of invoice. If payments are not made when due, Purchaser shall pay, in addition to the overdue payment, a late charge equal to the lesser of 1 ½ per month or the highest applicable rate allowed by law on all such overdue amounts.
